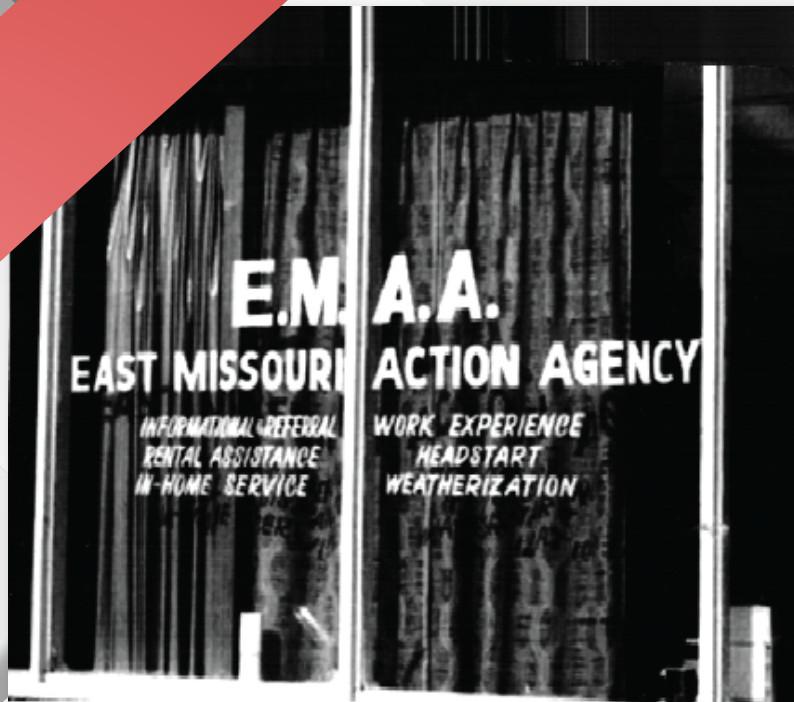

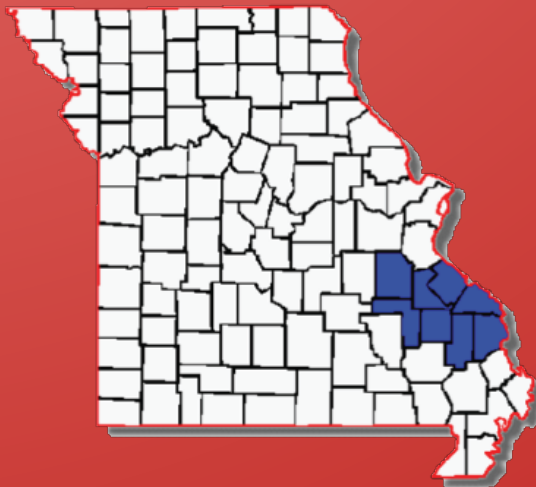

Through Head Start, EMAA provides a strong educational foundation for young children to be successful when they enter public school. EMAA provides resources for economic development in its service area in the form of small business loans to those who otherwise would not qualify due to their distressed situation. And, in response to the ongoing healthcare crisis in our country, EMAA provides women's wellness programs to assist in maintaining good health as well as, providing preventive services, and assistance if there is a health issue that requires immediate attention.

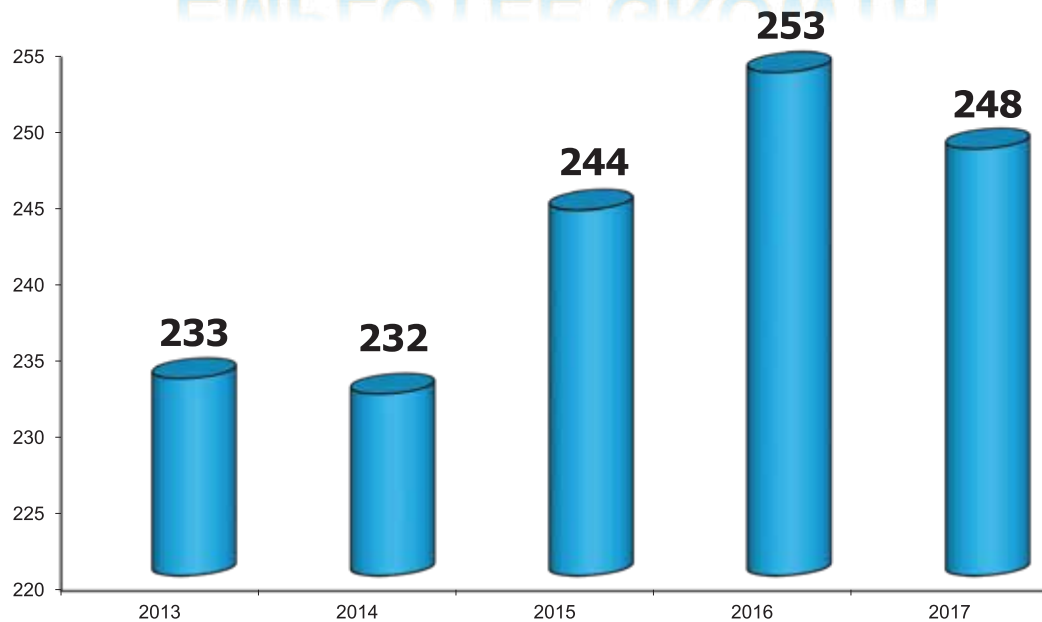

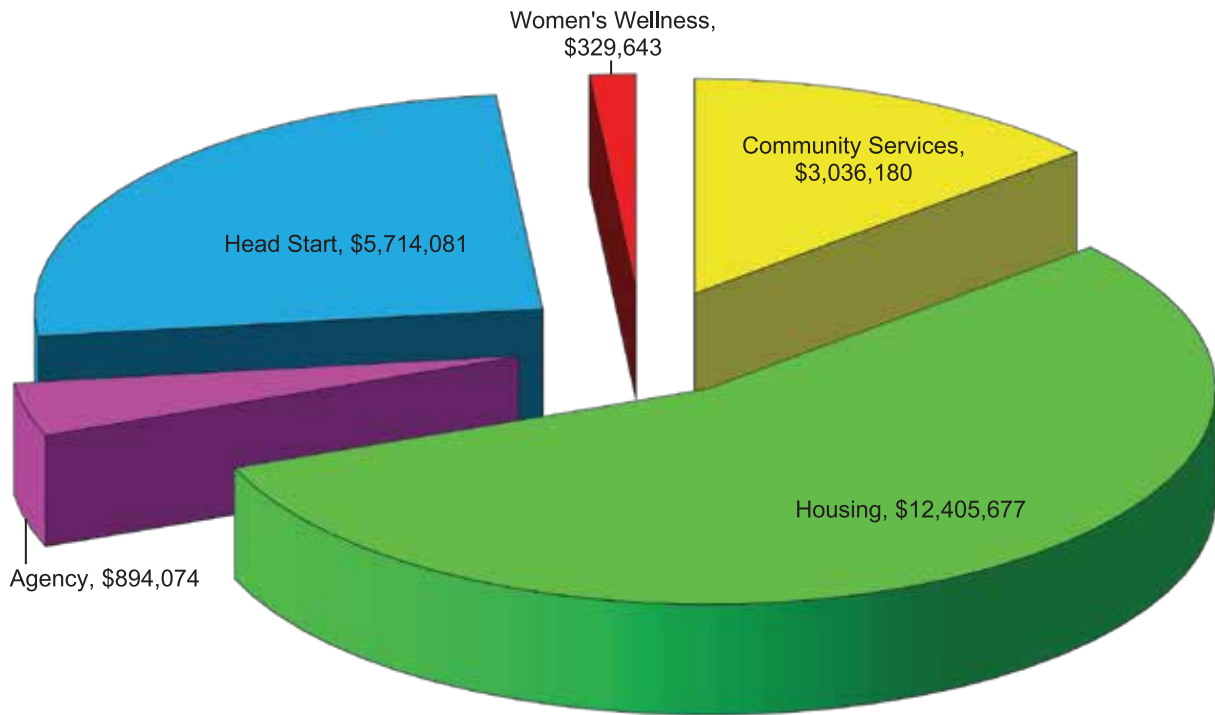

OUR SUCCESS IN NUMBERS

Community Services	<ul style="list-style-type: none"> ◆ 1493 households received assistance with federal and state tax returns resulting in \$1,107,496 in tax credits. ◆ 15,755 volunteer hours were contributed to the agency with 11,324 hours contributed by low-income individuals. ◆ East Missouri Action Agency has 84 partners in the service area. ◆ 7,286 families who received heating assistance. ◆ 12,845 nutritional meals served to low-income children through the Summer Food Feeding Program. ◆ 69 youth participated in Reality Enrichment and Life Lessons (REALL) Project, a simulation designed to challenge youth to think critically about how choices and decisions made in adolescence may have consequences in adulthood. ◆ Through the SEMO Assets Program in Community Services and the Family Self-Sufficiency Program in Housing, 19 individuals increased their savings by a total of \$21,563. Also Through the SEMO Assets Program, one participant started a new small business, while another one was able to expand a current business with their savings. ◆ Step Up to Leadership – One successful graduate in 2018.

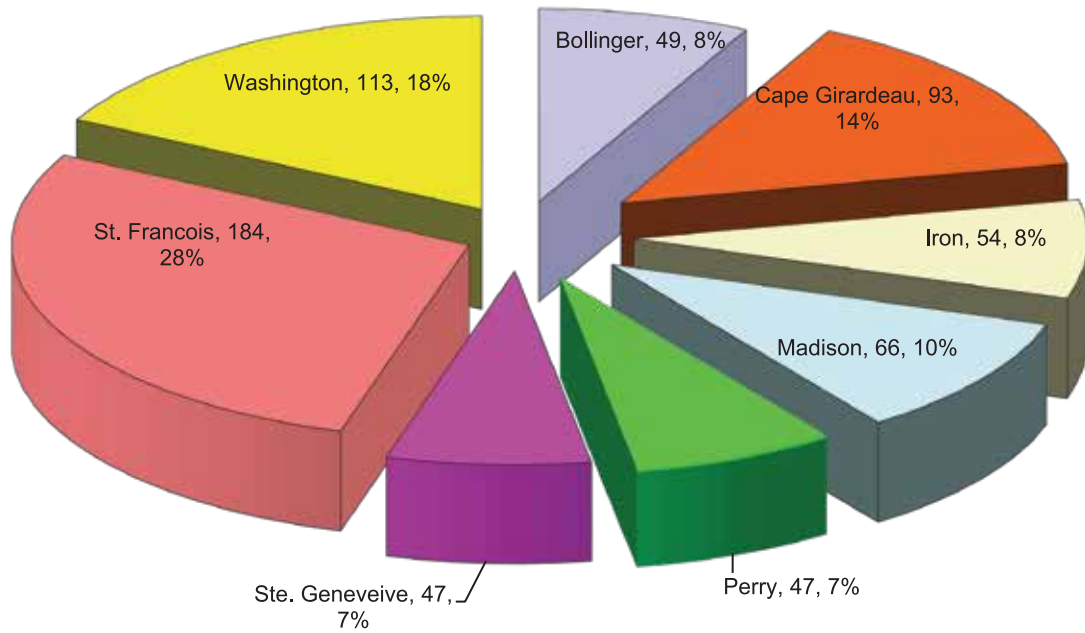
Well done Trixie!

Women's Wellness Center 2018

Women's Wellness Center provides comprehensive reproductive health services and education to women, men, and adolescents in Park Hills, Cape Girardeau, and Fredericktown. We offer two programs, Title X and Show Me Healthy Women program, through which we deliver a number of services including annual preventive exams, cervical and breast cancer screening, sexually transmitted infection screening and treatment, vaginal infection diagnosis and treatment, full range of contraception, including long acting reversible contraception (implant and IUD;s), pregnancy testing and counseling.

This year, we served 1,097 unduplicated clients through 1,828 provider visits. Approximately 75% of our clients fall below 100% Federal Poverty Level and have no or very nominal cost for services they receive. Of those serviced we provided:

- 370 cervical cancer screenings
- 373 clinical breast exams, with 26 referrals due to abnormal findings
- 810 sexually transmitted infections screenings

We are proud of our collaboration with Missouri Baptist Breast Care Center which provides women in our community's access to life saving breast cancer screening. We have also partnered with Southeast Missouri State University to bring sexually transmitted infection screening services to students, at least four times per year.



Our Nurse Practitioner, Lucia Obergöenner, was recognized by the National Family Planning Reproductive Health Association as a Family Planning Champion for her dedication to the field of reproductive health and her clients.

Our goal is to provide up-to-date client-centered care to each and every one of our clients, to make them feel comfortable and help them realize and achieve their reproductive health goals, decrease the number of unplanned pregnancies, promote well-being and optimal health, and promote disease prevention.

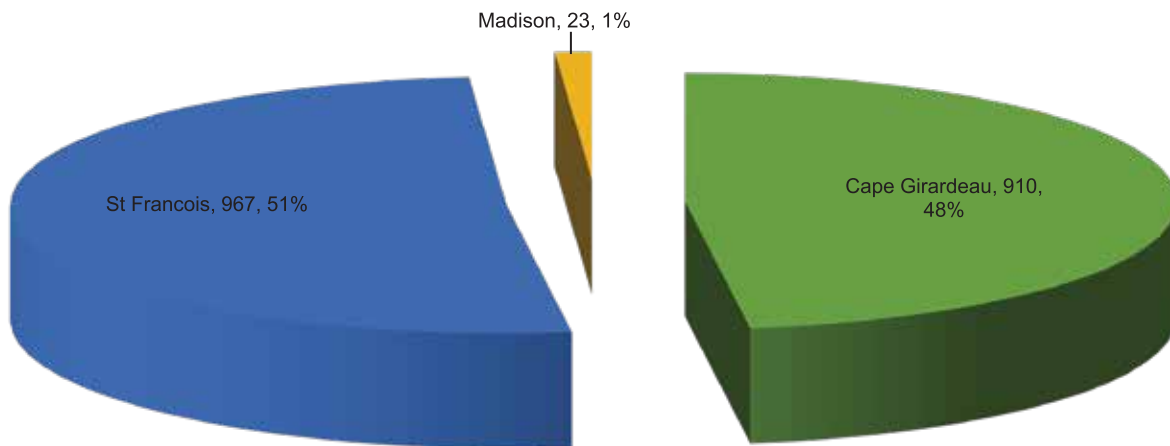

COMMUNITY SERVICES

Through the Community Services Department, EMAA assists people in several basic service areas, including Family Intake, Assessment, and Referral (FIAR); income tax preparation; energy assistance programs; emergency assistance; and community resource development.

One aspect of EMAA's Community Services is known as Community Coordination and Resource Development. EMAA coordinates with other local resources to develop new programs and partnerships to bridge gaps and eliminate overlaps in services.

The Low-Income Home Energy Assistance Program is administered as part of EMAA's Community Services Department. LIHEAP is a federally funded energy program designed to assist low-income families with their energy needs. Dollar More, Round Up, and Dollar Help are all privately funded emergency energy programs sponsored by the customers of AmerenUE, Citizen's Electric, and Laclede Gas, respectively. Through our winter energy assistance programs, we were able to ensure that 7,286 families stayed warm.

Another component of Community Services is the Poverty Simulation Project. This program is designed to educate the public on the dynamics of living in poverty by having them participate in a virtual "month in the life" of a family in poverty.

The SEMO Assets Individual Development Account Program allows eligible, motivated families to save money for the down payment on a house, to start a small business, or to provide a family member with post-secondary education.

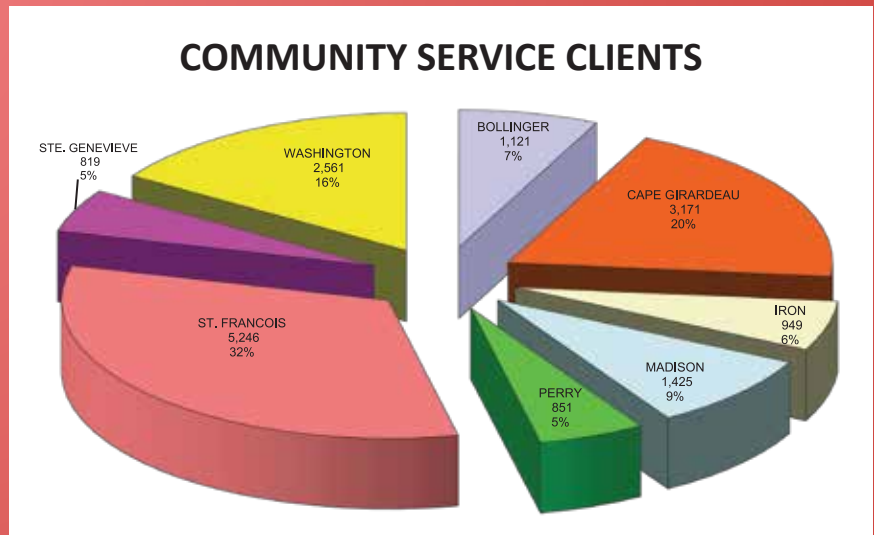
Our Reality Enrichment And Life Lessons (REALL) project is a simulation designed to challenge youth to think critically about how choices and decisions made in adolescence may have consequences in adulthood. During a REALL Simulation, youth encounter issues such as lack of education due to dropping out of school, not enough income, being labeled as an ex-offender, unplanned pregnancies, etc. They will have to make real decisions, and experience how those decisions can affect their futures. In 2018, over 69 youth participated in a REALL Simulation, which proved to be a REALL eye-opener for them.

Here at EMAA, we also have a project called Volunteer Income Tax Assistance (VITA). Through this program, we offer free tax help to people whose income falls within the guidelines. The free assistance is provided by volunteers who receive IRS based training on how to prepare basic returns, and they must pass the IRS Certification Test. The VITA Program is conducted in all of our county outreach offices, and last year, we prepared 1,493 tax returns for low-income and senior citizen/disabled households.

This service resulted in:

- ◆ \$1,107,496 in refunds being brought back into our communities.
- ◆ 7,286 families received winter energy assistance.
- ◆ 69 youth participated in REALL.
- ◆ 1,493 tax returns for low-income and senior citizen/disabled households.
- ◆ 3 Step-Up-To-Leadership graduates.
- ◆ 12,845 meals served in four counties through the Summer Food Service Program.

COMMUNITY SERVICE SUCCESS STORY 2018

Helping People, Changing Lives: This is a phrase we often use within the Agency. Letitia Dixon is a wonderful example of how EMAA staff and services helped Letitia change her life.

When Letitia first came to EMAA, she was facing many barriers to success, including being homeless, no transportation and a limited income. While staying at Shared Blessings, a local shelter, she became connected with a program to assist seniors who wanted to work. Our St. Francois County Outreach Office needed a receptionist and ultimately she was placed in our office on a paid-work experience program. While there, she improved her customer service skills, computer skills, general office skills and work ethic.

As her personal confidence grew, Letitia enrolled in and completed our 12 week Step-Up-To-Leadership Class. A component of this course focuses on the value of serving on local boards. Letitia ran for a seat on the EMAA Board and was elected to serve. She currently represents low-income families on the EMAA Board of Directors.

Letitia now works as an office assistant at the L.I.F.E. Center for Independent Living where she applies the skills she gained working at our office. She has her own apartment and helps others with disabilities by being involved in the many activities at the BJC Clubhouse in Farmington, MO.

Helping Letitia reach her highest possible level of success was our goal. She knew what she wanted to change her life for the better and she is an example of what is possible when personal commitment and opportunity come together.



HOUSING DEPARTMENT

EMAA's Housing Department administers a variety of Housing related programs. EMAA in conjunction with the St. Francois County Public Housing Agency administers the Section "8" Housing Choice Voucher Program funded by the Department of Housing and Urban Development (HUD). This program is designed to assist income eligible individuals and families with rental assistance payments.

The Federal Government has determined income eligible recipients should not pay more than 30% of their monthly adjusted income. This is the determining factor on the amount the Housing Assistance Payment will be made on behalf of the recipient.

During fiscal year 2017, EMAA was able to provide rental assistance payment for

2,157 income eligible households

5,337 individuals

\$9.25 million in rental payments over an eleven county area

EMAA also administers a rental assistance for eligible recipients program through the Missouri Department of Mental Health called Shelter Plus. This program is funded to assist approximately 20-25 families or individuals.

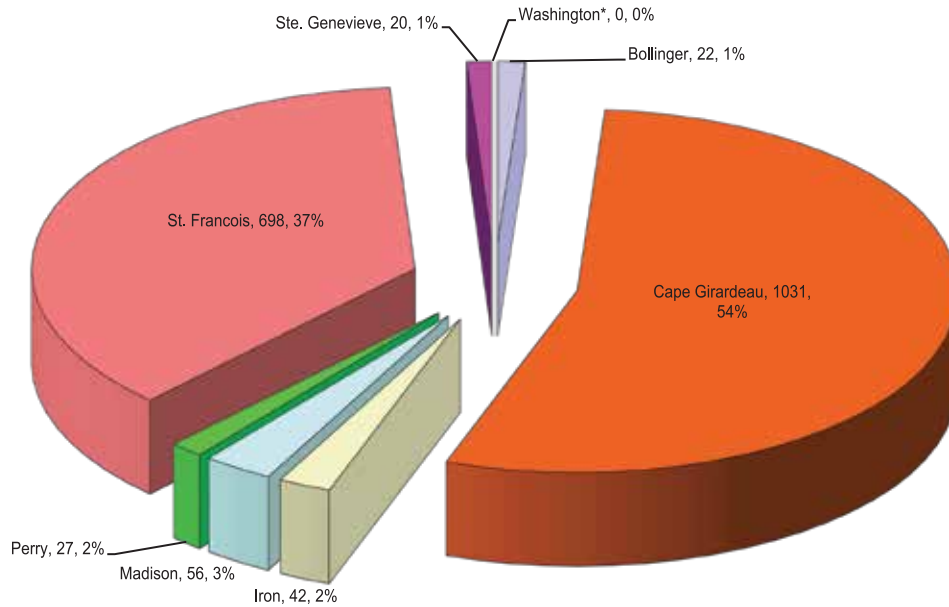

In addition, EMAA received funding from USDA Rural Development and Missouri Housing Development Commission (MHDC) to rehabilitate homes occupied by owners who otherwise could not afford to make the repairs. Home owners must meet income guidelines established by the funding sources. The primary goal of EMAA is to ensure once the repairs are completed the home provides a safe, sanitary, and decent place to reside for the homeowner.

Housing Department Success Story

Ms. Amber Whaley, a single mother of four, began receiving rental assistance under Section 8 Housing Voucher program funded by the Department of Housing and Urban Development in August, 2011.

Ms. Whaley requested and approved to be enrolled in the Family Self- Sufficiency (FSS) Program on September 1, 2014. At the time of enrollment, Ms. Whaley's only income was SSA. In November 2014, she secured employment and began escrowing funds as allowed under FSS guidelines. Ms. Whaley, along with FSS Coordinator, Ms. Hawkins, set objectives for Ms. Whaley which would immediately allow her to reach the goal of becoming a home owner. This had to be accomplished within a five year contracted agreement.

After four years of hard work and meeting her objectives, Ms. Whaley was still facing a few debts that had to be cleared prior to securing a loan to purchase a home that would provide her family with the security she desired.

Ms. Whaley requested and was approve to utilize funds from her escrow account to Clear those debts. Once these issues were addressed Ms. Whaley applied for a loan Through USDA Rural Development. With her debts cleared, and through the help of EMAA Home Ownership Program, she was able to secure the USDA loan and has since purchased a home for her and her family.

To say this was completed and Ms. Whaley was a success in her mission to secure that dream is not that simple. Ms. Whaley had money struggles and issues in that five year span. However, she had the desire and drive to accomplish that dream of becoming a homeowner. SHE made it happen!

2018 Summer Food Service Program



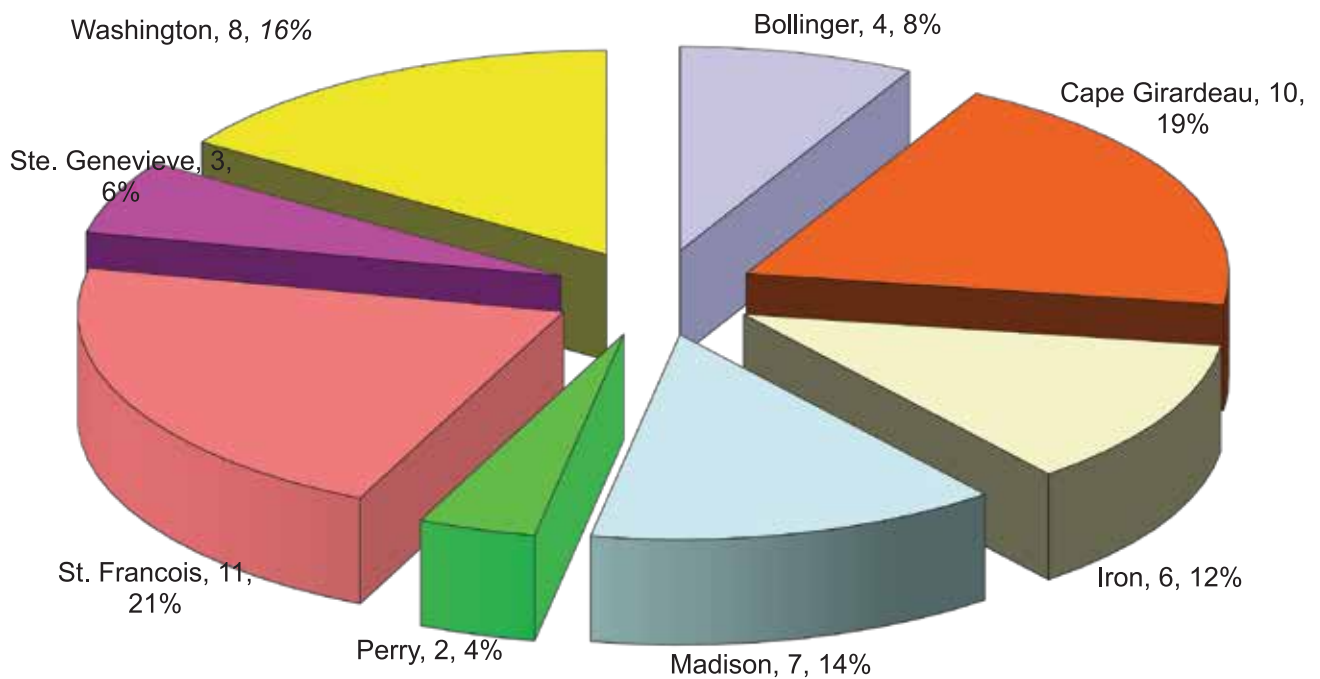
Children need good nutrition all year long. When school is out during the summer months, many children no longer have access to even one nutritious meal each day. Summer Meal Programs help to fill the gap.
